1. Overview

Your privacy and the protection of your personal data are important to us. This Privacy Policy explains how **APPIFY STUDIOS LLC** ("we", "our", or "us") collects, uses, stores, and protects information when you use the **Wildscat: Animal Scat ID** mobile application and related services.

By using the Application, you consent to the practices described in this Privacy Policy. If you do not agree with this Privacy Policy, please do not use the Application.

Privacy summary: Wildscat analyzes photos you choose to submit, may use optional location context when you enable it, and uses purchase information only to manage premium access. We do not sell your personal information. We do not use your photos for advertising, and we do not intentionally store submitted photos permanently after analysis.

2. Information We Collect

2.1 Information You Provide

We collect information that you choose to provide while using the Application, including:

- Photos you capture or upload for animal scat, dropping, or wildlife sign identification
- Saved identification results and analysis history
- Optional location information for detailed analysis or map features
- Environmental context you provide, such as weather, habitat, season, time of day, freshness, size, or notes
- User preferences, app settings, and feature choices
- Support messages or information you send when contacting us

2.2 Automatically Collected Information

When you use the Application, we may automatically collect:

- Device information, such as device model, operating system version, language, and app version
- App usage, diagnostics, crash logs, and performance information
- Subscription status and anonymous purchase identifiers for premium access management

- Local app preferences and settings
- Approximate or precise location data only when you grant permission and use location-based features

2.3 App Store Privacy Categories

Depending on how you use the Application, the data categories associated with the Application may include:

- **Photos or videos:** Images you submit for identification
- **Location:** Optional precise or approximate location used for discovery logging, maps, or detailed analysis
- **Identifiers:** Anonymous user or purchase identifiers used for subscriptions, support, and service functionality
- **Purchases:** Subscription status and product identifiers used to unlock premium features
- **Usage data and diagnostics:** App interactions, crash logs, and performance data used to improve reliability

2.4 Permissions Required

The Application may request the following permissions:

- **Camera:** To capture photos for identification
- **Photo Library:** To select existing photos from your device for analysis
- **Location:** To save discovery locations, support detailed analysis, and display findings on a map when you choose to use these features

Permissions are requested only when needed and can be managed from your device settings.

3. How We Use Information

We use collected information to:

- Analyze submitted photos and provide animal scat identification results
- Generate detailed observations and educational information about possible wildlife species
- Save and display your analysis history and discovery locations
- Improve app functionality, reliability, accuracy, and user experience
- Process in-app purchases and manage subscription access
- Respond to support requests and service-related inquiries
- Detect, prevent, and troubleshoot technical issues, fraud, misuse, or security problems
- Comply with legal obligations and enforce our terms

4. Data Storage and Processing

4.1 Local Storage

The following information may be stored locally on your device:

- Identification history and saved results

- Saved discovery locations
- User preferences and app settings
- Usage counters or premium feature state
- Subscription access state

4.2 Image Processing

Photos submitted for identification may be transmitted to our servers or trusted service providers for AI-powered analysis. These photos are used to provide the requested identification result and related analysis.

We do not sell your submitted photos. Photos are not used for advertising. Photos are not intended to be stored permanently after processing unless a feature you use requires temporary storage, you explicitly save related results, or temporary retention is required for security, troubleshooting, or abuse prevention.

4.3 Location Data

Location data is used only when you grant permission or manually provide location information. It may be used to:

- Save where a discovery was made
- Display findings on an interactive map
- Improve detailed analysis by considering regional context
- Provide location-relevant suggestions or observations

Saved discovery locations are primarily stored locally on your device. When you submit a detailed analysis, relevant location information may be sent to our servers to improve the requested result.

5. Information Sharing

We do not sell, trade, or rent your personal information. We may share information only in the following circumstances:

- **Service Providers:** With providers that help operate the Application, including hosting, AI processing, diagnostics, subscriptions, and payments
- **Legal Requirements:** When required by law, regulation, legal process, or to protect rights and safety
- **Consent:** When you explicitly direct us or consent to a specific sharing activity
- **Aggregated Data:** We may share anonymized or aggregated information that cannot reasonably identify you

5.1 Third-Party Services

The Application may use third-party services including:

- **RevenueCat:** Subscription and in-app purchase management
- **Apple App Store:** Payment processing and app distribution on iOS
- **Google Play Store:** Payment processing and app distribution on Android
- **AI service providers:** Image analysis and generation of identification results
- **Map or location services:** Displaying saved discovery locations when map features are used

- **Cloud and diagnostics providers:** Hosting, service reliability, crash reporting, and troubleshooting

These providers process information according to their own privacy policies and their agreements with us, where applicable.

5.2 No Sale of Personal Information

We do not sell your personal information, photos, location data, or analysis history. We also do not share your personal information with third parties for cross-context behavioral advertising.

5.3 Legal Basis for Processing

Where required by applicable law, we process personal information based on one or more of the following legal bases: your consent, performance of a contract with you, our legitimate interest in operating and improving the Application, compliance with legal obligations, and protection of our rights, users, and services.

6. Data Security

We use reasonable technical and organizational safeguards designed to protect your information, including secure communications, access controls, and appropriate storage practices.

No method of transmission over the Internet or electronic storage is completely secure. While we work to protect your information, we cannot guarantee absolute security.

7. Your Rights and Choices

Depending on your location, you may have rights to access, correct, delete, restrict, object to processing of, or request portability of your personal information.

You can manage many choices directly through the Application or your device settings, including:

- Deleting saved history or local app data where available
- Revoking camera, photo library, or location permissions
- Managing or cancelling subscriptions through the relevant app store
- Uninstalling the Application to stop local data collection

To make a privacy request, contact us using the information in the Contact Us section. For security, we may need to verify your request before taking action. We will respond within a reasonable timeframe and in accordance with applicable law.

8. Data Retention

- **Identification history:** Stored locally until you delete it or uninstall the Application
- **Photos:** Processed to provide the requested result and not intended for permanent server storage; temporary copies may be retained only as needed for processing, security, or troubleshooting
- **Location data:** Stored locally when saved by you; submitted location context may be processed for detailed analysis
- **Subscription data:** Retained as needed to provide premium access, comply with legal obligations, and resolve billing issues

- **Diagnostics:** Retained for a reasonable period to maintain security, debug issues, and improve app performance

9. Children's Privacy

The Application is not intended for children under 13 years of age. We do not knowingly collect personal information from children under 13. If you believe a child has provided us personal information, please contact us and we will take appropriate steps to delete it.

10. International Data Transfers

Your information may be processed in countries other than your country of residence. These countries may have data protection laws that differ from those in your jurisdiction. We take reasonable steps to protect information in accordance with this Privacy Policy.

11. In-App Purchases and Subscriptions

Premium features may be offered through in-app purchases or subscriptions managed by RevenueCat, Apple App Store, or Google Play Store. Payment information is processed by the relevant platform or payment provider. We do not receive or store your full credit card information.

We may receive subscription status, transaction identifiers, product identifiers, and purchase history needed to provide premium features and support purchases.

12. Accuracy of Identification

The Application uses image analysis and artificial intelligence to identify animal scat and related wildlife signs. Results are provided "as is" for educational and observational purposes and may be inaccurate or incomplete.

Do not rely solely on the Application for safety, health, scientific, legal, hunting, wildlife management, or regulatory decisions. Consult qualified experts or local authorities where accuracy is important.
